# COOKIES POLICY

Cookies consist of information, often containing a unique, anonymous identification code, that is sent to the browser by a web server and it is stored on the hard drive of the user's computer. Later on, if there are new connections to the website, cookies can be read and recognised by the website that sent them. Cookies are used mainly to operate with and enhance the operations of websites and to provide sales and marketing information to the owner of the website.

What are third-party cookies? Third-party cookies are the cookies installed by a website which is not the one you are visiting right now.

- 1. Cookies that are strictly necessary: these are essential to enable surfing on our website and to use its different functions. These cookies do not gather information on the user that may be used for marketing purposes, and neither do they allow monitoring of the user's surfing on the web.
- 2. Cookies for statistical analysis: These cookies allow us to quantify visitor figures and statistically analyse the use of our services by users. Thanks to this we can analyse surfing on our website and enhance our product and service offer.
